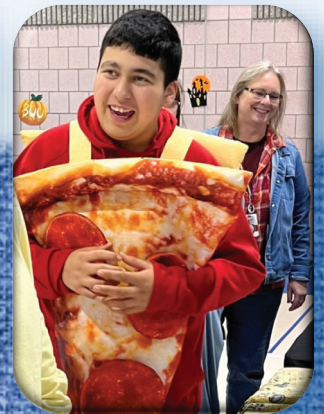

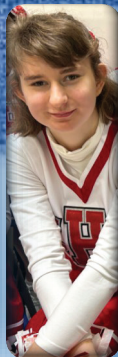
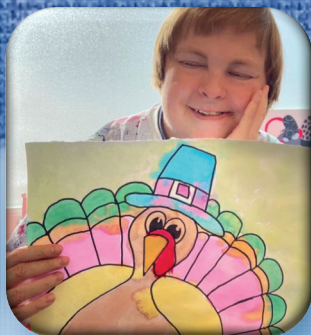

This year in addition to working on enhancing our programs and keeping up with technology, we undertook several much needed projects—ones that are usually missed by observant eyes but, none the less, were important changes for the health and safety of the children.

We were able to: installed a new Sewage Treatment Plant Monitoring and Control System; replace a twenty-ton HVAC compressor and a ceiling mounted heater; upgrade room heating units ; replace two water heaters.; add light-weight vacuum cleaners for classroom use to our transition-to work instruction program; include paving repairs on the campus roadway; add a boiler room alarm control system that includes the swimming pool filter alarms as well; make campus LED light installations; replace carpeting in several classrooms, in the Center, and hallways; install new skylights; replace roofing on sections of the kitchen and Clelian Center; make chapel roof and ceiling repairs. Progress on the Café continues with countertops, cabinetry, flooring and wall painting completed.

Donor Advised Funds—DAFs

Have you heard about **Donor Advised Funds**, also known as **DAFs**? Many donors are setting up **DAFs**, allowing them to make charitable gifts to nonprofit organizations. A **DAF** is essentially your “giving account” established with a public charity, allowing you to receive an immediate tax deduction and to recommend grants (charitable donations) from the fund.

How does it work?

You may contribute cash, investments or appreciated assets. **2) Second**, invest your assets with the help of your investment provider. **3) Third**, recommend grants to a recognized 501(c)3 charitable organization, such as **Clelian Heights Inc.**

Why is a DAF a good idea? Having a **Donor Advised Fund** allows you to be intentional about your charitable giving. The money is already set aside for the purpose of giving it away and making a difference in the lives of others.

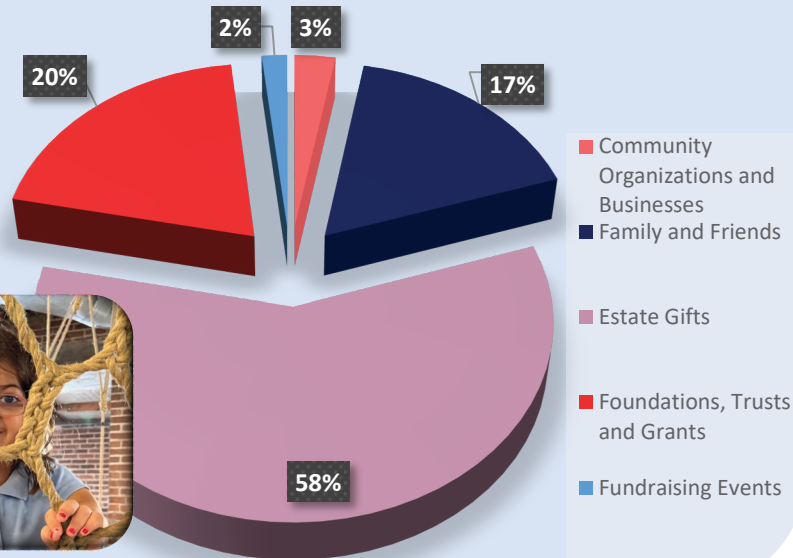
